INFORMATION FOR A LEVEL STUDENTS REVIEW OF RESULTS AND RETURN OF SCRIPTS

If your results are not what you expected, there are a few options. Speak to your subject teacher in the first instance who will advise you of how close to the grade boundary your grade is and if it is worth requesting a review of marking. But remember, **there is no grade protection for reviews of marking. This means that your grade may be lowered, confirmed or raised as a result.** This needs to be considered before signing the consent form.

University place pending - we advise that you request a Priority review of marking.

No university place pending - you can request a Priority copy of marked paper to decide if you would like a review of marking.

PROCESS FOR PRIORITY REVIEW OF MARKING

1. Talk to your subject teacher
2. Sign the consent form (overleaf) and return to the Exams Officer by 11am on Thursday 22nd August. Exam boards will not accept requests after this deadline. **An email confirmation that you have read and understood the consent form will be accepted**

Please note

- All review requests must be made through the school. Students cannot directly contact exam boards
- Fee payment will be required (notification by e-mail) once the request has been sent to the exam board. If the outcome results in grade change students will be refunded. Students who receive Free School Meals will not be charged.

If you sat some of your exams at a consortium school, applications for post results services must be submitted through that school and not through Townsend.

Post-Results Service	Details of the service
Review of marking	This is a post-results review of the original marking to ensure that the mark scheme has been applied correctly... Reviewers will not re-mark the script. They will only act to correct any errors identified in the original marking.
Review of marking with post-review of marking copy of script	
Priority Service: Review of marking	This is the same service as Review of Marking, but the script is reviewed as a priority, therefore a request for this service must be submitted to the earlier deadline. (This service is only available for GCE A-level and Level 3 VTQ qualifications)
Priority Service with post-review of marking copy of script	
ATS: Copy of script to support review of marking	This is a priority service that ensures copies of scripts are returned in sufficient time to allow decisions to be made whether a non-priority review of marking should be applied for
ATS: Copy of script to support teaching and learning	This is a non-priority service to request copies of scripts to support teaching and learning
